#### **SUB-COMMITTEE UPDATES:**

<u>Investigation Committee:</u> There was one grievance. The Investigation met and has resolved the issue.

Technology Committee: Video to be placed on the website after captioning is complete per Daisy. Stephanie Ott has reached out to the people captioning our video. The ASL description of our licensure law and the bylaws was done by one interpreter Melina. Ad Hoc Committee: Research into the levels for QAST and BEI for Arkansas is being conducted. New information will be brought to the board in November per Katie. Licensure Committee: Per Cheryl Seymore with Arkansas Rehabilitation Services (ARS), support will be given to QAST holders with expiring credentials while having a current Arkansas license. Monthly emails with QAST certified summary – any expiring credentials applicant will receive a letter from the Licensure committee stating that he/she will have 14 days to renew QAST certifications. No renewal will trigger an investigation. Hopes to reduce the number of interpreters without up-to-date credentials.
