

First Quarter Report July – September 2019

PRESCRIPTION DRUG MONITORING PROGRAM



New User Accounts

By the end of September 2019, the Arkansas Prescription Drug Monitoring Program (PDMP) had over 22,358 active user accounts. During the first quarter of FY2020, the highest increase in user accounts was for the Prescriber Delegate – Licensed and Prescriber Delegate – Unlicensed, with 211 and 149 new user accounts, respectively.

PDMP Use

The use of the PDMP system has evolved to include in-state patient searches in the AR PDMP database, out-of-state patient searches of the AR PDMP, and patient searches initiated through integrated systems that combine the AR PDMP into electronic health records (EHR) and pharmacy dispensing software (PDS). Each method of query (in-state PDMP database, out-of-state, integration) will be calculated and reported separately. This will more accurately portray the continued evolution of the use of the AR PDMP.

During the first quarter of FY2020, the integration numbers for pharmacists from July to September increased from 2,509,929 queries to 4,068,328 queries – a 62% increase (Table 2).

From July to September, the overall query counts for prescribers increased (Table 3). The AR PDMP query numbers have been going down, and the integration query numbers have been going up, as more providers are integrating the PDMP into their EHRs.

The number of queries performed by law enforcement and professional boards was the highest in the month of August, with 122 queries by law enforcement and 52 queries by professional boards (Table 4).

Interstate Data Sharing

The PDMP system is capable of sharing data with other state and federal PDMPs. Arkansas's PDMP currently shares data with 37 other states, Puerto Rico and the Military Health Systems (MHS) PDMPs (Figure 1). The MHS PDMP shows the controlled prescriptions filled on military bases both in the United States and bases located abroad. The St. Louis County PDMP in Missouri and the Arkansas PDMP started sharing in September of 2019. The St. Louis County PDMP currently obtains data from 75 participating jurisdictions, covering roughly 85% of the state's population and 94% of medical providers.
